

## MEETING OF THE STATE BOARD OF AGRICULTURE

## President's Office.

August 20, 1920.

1:00 P.M.

Present, President Kedzie, Messrs. Wallace, Woodman, Waterbury and Watkins.

On motion of Mr. Wallace, the following resolution was adopted:

Resolved, That the terms of a certain agreement under date of Aug. 20, 1920, between the Pere Marquette Railway and State Board of Agriculture, relating to the construction of a coal pit under the tracks of the Pere Marquette Railway Company, as submitted by that company, are hereby accepted and the secretary of the State Board of Agriculture is authorized to sign the contract.

The Secretary presented a letter from Junius E. Beal of the Board of Regents of the University of Michigan inviting the Board of Agriculture to be represented at the Inauguration of President Marion L. Burton.

On motion of Mr. Woodman, President Kedzie and Mr. Watkins were appointed to represent the Board on the above occasion, some other member to be appointed in case either cannot attend.

On motion of Mr. Wallace, \$1872.72 were added to the apportionment of the Department of Physical Training to cover the expenses of seating purchased for general college purposes.

The Secretary presented the College Extension Budget for adoption, accompanied with the following statement:

"STATE BOARD OF AGRICULTURE,

Gentlemen:-

The Extension budget for 1920-21, submitted by Director Baldwin and approved by the Secretary of Agriculture, has not as yet been passed upon by your body, and, while it may be too late to make material changes, I think certain matters relating to it should be called to your attention.

The total amount of Smith-Lever-Federal funds available is \$148248.21 and the offset required of the College is \$138248.21. Of this amount Mr. Baldwin recommends that \$93167.27 be paid from College funds and the remainder (\$45080.94) be offset with county funds. You should know, however, that the estimated amount to be paid out by the counties is \$94080.00, or, in other words, the College will pay out of its funds \$48999.06 more than is required to offset the Federal funds. If this is your desire, then the budget as presented will accomplish substantially that result. If however, you wish to limit the amount of College funds to be expended for extension work to the minimum compatible with the Federal Government's requirement, then a very considerable re-adjustment will be necessary, and this is not easily done, after nearly two months of the fiscal year have gone by."

On motion of Mr. Woodman, the matter was referred to the Secretary and Director Baldwin for report and recommendation.

On motion of Mr. Woodman, it was decided that Mr. Olmsted of Boston should be invited to be present at the next meeting of the Board to present matters relating to the location of new buildings.

On motion of Mr. Wallace, the construction of an elevator and hay storage shed was authorized.

On motion of Mr. Wallace, authorization was given to various persons to attend various scientific meetings as shown below:

Committee appointed to attend Presidential inauguration at Ann Arbor.

Professor A.J.Patten to attend the annual meeting of the American Chemical Society at Chicago, September 7 to 10, with all expenses paid; Dr. C.S.Robinson to attend the annual meeting of the American Peat Society at Madison, Wisconsin, September 2 to 4, with transportation expenses paid, and Dr. Robinson was authorized to invite the Society to hold its next annual meeting at Michigan Agricultural College; Mr. Newlon to attend the International Meeting of Instructors and Investigators at Purdue, August 16 to 20, with expenses paid; Dr. Hibbard to attend the meeting of the American Chemical Society in Chicago, September 7 to 10, with transportation expenses paid; Dr. McCool and Mr. Levin to attend the meeting of the American Peat Society at Madison, Wisconsin, September 2 to 4, with transportation expenses paid; Dr. Chandler to attend the meeting of the Veterinary Medical Association at Columbus, with all expenses paid.

The President presented certain correspondence between himself and Mr. G. H. Fenkell of Detroit, which on motion of Mr. Waterbury was referred to the Board of Directors of the Club Boarding Association.

Correspondence from Fenkell

On motion of Mr. Waterbury, the recommendations contained in the following letter from Director Baldwin were approved:

Dear Dr. Kedzie:

The following items are submitted for consideration by the Board of Agriculture.

Recommendations from Baldwin approved.

We desire the appointment of Mr. Clifford Patch as Assistant Field Agent in Marketing to succeed Mr. Raviler, Mr. Patch's appointment should be made effective September 1st at \$3500 per annum. His appointment is recommended by Mr. Tennant upon his record in organization for marketing in Montcalm County. The officers of the County Farm Bureau have agreed to release Mr. Patch if he is needed for this work.

A letter of resignation has been received from Mr. H. L. Barnum, County Agent for Missaukee. Mr. Barnum wishes this to be effective September 1st. He plans on returning to his own farm.

Barnum resigns.

In May an item was submitted in regard to making Mr. Robey's salary \$3200 instead of \$2800. Final action will need to be taken on this in order to retain Mr. Robey for the year.

Robey's salary increased.

The following adjustments of salaries need to be made to correspond with financial cooperation available from Bureau of Markets and Dairy Division:

On Extension Payroll Mr. Tennant should be increased from \$700 to \$900. Mr. Cribbs should be decreased from \$3000 to \$2600. Mr. Waldron should be increased from \$1820 to \$3200.

Other salary increases.

These adjustments will make the amount received equal to the contracts now held, and should be effective July 1st, 1920.

County Club Leader Personnel.

On motion of Mr. Waterbury, Miss Hazel Skelton was appointed stenographer at a salary of \$1300, beginning August 1st, to be paid from Extension Lever State funds, classified as Salaries b, Markets, and Miss Sarah Helmick was appointed stenographer at a salary of \$1200 beginning August 1, paid from Extension Lever funds, classified as Salaries b, Boys and Girls Clubs.

On motion of Mr. Watkins, \$2200 was added to the apportionment for the Alumni Recorder.

On motion of Mr. Woodman, the Secretary was directed to purchase from Mr. Robert D. Graham the fifty acres of land lying adjacent to the Graham Horticultural Experiment Station at \$12000.

On motion of Mr. Woodman, the matter of the purchase of certain farm tools and horses listed by Mr. H. D. Hootman, Supt., was referred to Dean Shaw with power to act.

Mr. Waterbury presented certain correspondence, etc., with the palmer Brothers, which upon his motion was referred to Mr. Watkins, with power to act.

On motion of Mr. Waterbury, settlement of summer shool salaries on the basis of 10% of the March rate without the \$250 limitation was approved.

On motion of Mr. Waterbury, a Department of Health Service was established with a budget of \$1000.

On motion of Mr. Wallace, a Health Service fee was established of \$1.50 per term, to be collected from each student in advance; the same to cover free medical service, including sixty days in hospital. This fee is to apply to Short Course students the same as regular students.

On motion of Mr. Watkins, the resignations of Mrs. Frear, Assistant Professor of Domestic Art, Miss Edmonds, Dean of Home Economics, and Mr. Mitchell, Associate Professor of Public Speaking, were accepted.
