Minutes of the Meeting of the State Board of Agriculture January 27, 1938

The meeting was called to order at 10:20 A.M.

The minutes of the previous meeting were approved.

Two members took their places on the Board at this meeting: Mrs. Lavina Masselink of Big Rapids and Mr. J. J. Jakway of Benton Harbor, replacing Mrs. Matilda Wilson and Mr. Gilbert Daane.

On motion of Mr. Berkey, seconded by Mr. Halstead, it was voted, in fairness to Mr. Jakway (absent), to delay organization of the Board until the next meeting attended by all members of the Board.

RESIGNATIONS, APPOINTMENTS AND LEAVES

- Resignations 1. Resignation of Mr. Luke H. Kelly, supervising teacher in Agriculture, effective as of December 31, 1937. Mr. Kelly is now serving as Assistant State Supervisor of Agricultural Educa-
 - 2. Resignation of Dr. H. L. Barnett, Instructor in Botany on a one-year appointment, effective January 31, 1938. Further, recommendation of Dean Huston that Dr. Barnett receive an additional \$108.33 to complete payment for one-half year's work (ten months' basis).
 - 3. Resignation of Mr. Carl L. Gilmore, graduate assistant in Poultry Husbandry, effective January 20, 1938.
 - 4. Recommendation of Professor Applegate that Mr. W. E. Laycock, College Photographer, be placed on disability retirement, his services to be discontinued immediately but full salary continued to June 30, 1938. Further, recommendation of the Retirement Committee that Mr. Laycock be placed on permanent retirement, effective July 1, 1938 at an annual salary of \$759.00 per year.

On motion of Mr. Brody, seconded by Mr. Downing, it was voted to give Mr. Laycock a leave of absence on full pay to the end of the present fiscal year and to offer to him an opportunity to apply for permanent retirement effective as of July 1, 1938.

- 5. Appointment of Mr. Raymond M. Clark as Assistant Professor of Education, effective as of January 1, 1938 at a salary of \$2900.00 per year. Mr. Clark will replace Mr. Kelly (resigned) as supervising teacher of Agriculture in the Okemos schools.
- 6. Appointment of Mr. Ralph W. Lewis, now Assistant in Research in Plant Pathology at \$1200.00 per year, as full-time Instructor in Botany for the period February 1st to June 30th at a total salary of \$130.00 per month. Mr. Lewis replaces Dr. Barnett (resigned).
- 7. Appointment of Mr. E. N. Huby as College photographer, effective February 1, 1938 at a salary of \$3000.00 per year. Mr. Huby replaces Mr. Laycock, whose retirement is recommended above.
- 8. Recommendation that Miss Mary Hulse be reinstated as stenographer in the Department of Chemistry, effective January 1, at her former salary of \$90.00 per month, and that the name of Mrs. Susan Toaz be removed from the payroll as of the same date. Miss Hulse's name was temporarily removed on October 31st because of disability.
- 9. Appointment of Mrs. Nila B. Laidlaw as an additional teacher in Home Economics at Williamston for the period January 3rd to March 25, 1938, at a total salary of \$525.00 (to be reimbursed in full from State and Federal funds). This is the same project in Adult Education in Home Economics carried out successfully last year.
- 10. Recommendation that Dr. D. B. Meyer, now with the State Department of Health, be placed on the staff list as Lecturer in Immunology, effective as of September 1, 1937. Dr. Meyer will serve without remuneration from the College.
- 11. Recommendation that Dr. C. S. Bryan, Research Assistant in Bacteriology, receive the additional title of Instructor. This action should be retroactive to September 1, 1937, at which time Dr. Bryan was placed on College funds but the additional necessary title overlooked.
- 12. Recommendation for the employment of Mr. Ralph C. Bennett, of the Lansing Social Service Bureau, as special instructor in Sociology extension case work during a seventeen-week period beginning January 1, 1938 at a total salary of \$200.00.
- 13. Recommendation for the appointment of the following visiting instructors on the 1938 Summer Session staff:
 - 1. Dr. C. V. Millard, Department of Education, at \$400.00 for the Six Weeks' Session.

- 15. Appointment of Miss Jeanne Rooker as stenographer in the Conservation Institute, effective January 1, 1938 at a salary of \$90.00 per month. This is an additional position included in the budget of the Institute as set up for 1937-38.

15. Discussion of proposed Federal Poultry Research Laboratory.

On motion of Mr. Downing, seconded by Mr. Berkey, it was voted to instruct the Secretary to wire the U.S.D.A. urging them to locate the Regional Poultry Laboratory at Michigan State College, assuring them of the full and complete cooperation of the State Board of Agriculture. If the Department of Agriculture decides to locate the Laboratory here and desires the location at the corner of Mount Hope and Harrison Road, the President, Secretary and Treasurer are authorized to take such steps as are necessary to take up the options on the farms involved and acquire titles to the land and deed it to the Department of Agriculture.
